

Privacy Policy

Version 1 – January 2022

General

1. Mindlike B.V., a limited liability company, incorporated under laws of the Netherlands, with its corporate seat in Amsterdam, registered with the trade register under number 84087277 (“Mindlike”) respects the privacy of all third parties it has a (legal) relationship with, in particular their rights regarding the automatic processing of personal data. We have therefore formulated and implemented a policy on complete transparency with regard to the processing of personal data, its purpose(s) and the possibilities to exercise your legal rights in the best way possible.

Processing of personal data

2. “Personal Data” means any information relating to an identified or identifiable natural person (i.e. the ‘data subject’)
3. An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.
4. Mindlike (possibly) processes the following categories of personal data from you:
 - a. Name
 - b. Gender
 - c. Address
 - d. E-mail address
 - e. Telephone numbers
 - f. Birth date /age

Purpose and registration of processing

5. Mindlike does not collect your personal information without a purpose. Your

personal data is processed to maintain a relationship with you.

6. Your personal data is recorded in an (electronic) register.

Your rights regarding information

7. Pursuant to Section 13 Paragraph 2 Sub b of the Regulation (EU) 2019/679 (GDPR) each data subject has the right to information on and access to, rectification, erasure and restriction of processing of his/her personal data, as well as the right to object to the processing and the right to data portability.
8. You can exercise these rights by contacting Mindlike at info@mindlike.nl.
9. Each request must be accompanied by a copy of a valid identification, on which you put your signature and state the address where Mindlike can contact you.
10. Within two (2) months of the submitted request, you will receive an answer from us.
11. Depending on the complexity and number of the requests this period may be extended to three (3) months.

Legal obligations

12. In case of infringement of any law or regulation, of which a visitor is suspected and for which the authorities require the personal data collected by the collector, they will be provided to them after an explicit and reasoned request of those authorities, after which these personal data do not fall anymore under the protection of the provisions of this privacy policy.

14. Your personal data will not be used by Mindlike's partners for commercial purposes.

Data retention

15. The collected data is used and retained for the duration determined by law.

Other

16. Mindlike has the right to unilaterally amend this privacy policy.
17. This privacy policy and the legal relationship between Mindlike and you are governed by Dutch law. All disputes will be submitted exclusively to the competent court in Amsterdam.
